Personal data that we process

BEBR Football processes your personal data when you make use of our services and/or when you provide these to us yourself. Below you will find an overview of the personal data that we process:

- First and last name;
- E-mail address;
- Data on your activities on our website.

Special and/or sensitive personal data that we process

Our website and/or service has no intention of collecting data about website visitors who are younger than 16 years of age, unless they have permission from their parents or guardian. However, we cannot verify whether a visitor is over 16. We therefore recommend that parents be involved in the online activities of their children, in order to prevent data being collected on children without parental permission. If you are convinced that we have collected personal data on a minor without such consent, please contact us at info@bebr-football.nl and we will delete this information.

For what purpose do we process personal data?

BEBR Football processes your personal data to be able to email you if this is necessary for us to be able to perform our services.

How long we keep personal data

BEBR Football will not retain your personal data any longer than is strictly necessary for the purposes for which the data was collected. We will retain your personal details for a maximum of 2 years.

Sharing of personal data with third parties

BEBR Football will only provide personal data to third parties if this is necessary for the execution of our agreement with you, or to comply with a statutory obligation.

Cookies

BEBR Football only uses technical, functional and analytical cookies that do not infringe on your privacy. A cookie is a small text file that is stored on your computer, tablet or smartphone when you first visit this website. The cookies we use are necessary for the technical functioning of the website and your ease of use. They ensure that the website works properly and remembers, for example, your preferences. They also enable us to



optimise our website. You can unsubscribe from cookies by configuring your internet browser in such a way that it no longer saves any cookies. In addition, you can delete all information previously stored using your browser settings.

Reviewing, modifying or deleting data

You have the right to inspect, correct or delete your personal data. You also have the right to withdraw your consent for data processing or to object to the processing of your personal data by BEBR Football and you have the right to data portability. This means that you can submit a request for us to send the personal data we have on you in a computer file to you or another organisation named by you. You can send a request for inspection, correction, deletion, data modification or request to withdraw your permission or objection to the processing of your personal data to info@bebr-football.nl. To make sure that the request for inspection was made by you, we ask you to send a copy of your proof of identity with the request. In this copy, please redact passport photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and Citizen Service Number (BSN). This is to protect your privacy. We will respond to your request as soon as possible, but within four weeks. BEBR Football would also like to point out that you have the option of submitting a complaint to the national supervisory authority, the Autoriteit Persoonsgegevens.
